Atal Ranking of Institutions on Innovation Achievements (ARIIA) is an initiative of Ministry of Human Resource Development (MHRD), Govt. of India to systematically rank all major educational institutions and universities on indicators related to promotion of "Innovation and Entrepreneurship Development" amongst their students and faculties.

There are 7 parameters with sub-parameters to assess the existing innovation and start-up ecosystem at HEIs. Each parameter carries certain weightages out of total 100 marks.

- vii. Grant / Fund Generated / Received by Institute to support Innovation & Start-up
- viii. Venture Fund / Investment mobilized to support Innovation & Start-up
- ix. Revenue Generated from Incubation Services offered by the Institute

3. Awareness Activities for Promoting Idea Generation and Innovation (Allocated Weightage - 20 Marks)

- ii. Ideas to Innovations (Details can be submitted through Sub-parameter-(iv) of Parameter-1)
- iii. Student Projects recognized at National / International Level

4. Promotion and Supporting Entrepreneurship Development (Allocated Weightage - 20 Marks)

- iii. Patent Published, Patent Granted, Joint Patents with Industry, Patent Cited by other Patents (Data related to these will be obtained through third party, institutes need not to provide these at portal)

6. Innovative Learning Methods & Courses (Allocated Weightage - 10 Marks)

- Courses on Innovation, IPR and Entrepreneurship
- Faculties with Entrepreneurial Experience.

7. Innovations in Governance of the Institution (Allocated Weightage - 6 Marks)

Sub-parameters

- List and describe two best Innovations developed in-house and adopted successfully in last three years to improve the governance of Institute.

Institutes are requested to provide detailed information on above parameters (Except GREEN Marked Parameters and Sub-parameters) through ARIIA Data Submission Portal. Simultaneously, we also recommend institutions to systematically compile data along with original supporting documents which they need to furnish for verification whenever required.
